REQUIRED CLIENT ADMISSION PAPERWORK

- Bio Psycho-Social/Comprehensive Evaluation (within 1 year)
- Medical History & Physical
- Labs (CBC, UA & ALT) and PPD (within 1 year)
- Urinalysis
- Current medication list
- OASAS LOCADTR
- Legal Contact Information (Name, Address, and Phone #)
- Funding Information (Health Insurance Card, Policy Holders Name and SS#)

THE ADMISSION PROCESS

- 1. A review of the paperwork is conducted by our Clinical, Medical and Financial Staff.
- 2. The Admission Department conducts a phone screening/interview with the potential client.
- 3. The client, once approved, is placed on our waiting list for placement.
- 4. As soon as a bed is made available, our Admissions Team will contact the referring facility or clinic counselor so travel arrangements can be made.

To begin the admission process to the North Country Freedom Homes Men's Residential Program, complete pre-admission consent and send records for review. We have staff to answer questions, so please feel free to call or email. The list below will help you get started with the admission screen process.

Pre-Admission Consent

A Release of Information consent form signed by the client being referred must be submitted with the requested medical documentation. The consent form must be completed entirely with contact information for the facility or clinic, including name, address, phone number, and fax number. Please also include the referring staff member's name, phone number and extension, fax number if it is different from the facility or clinic's main number, and email address.

Records Request

Please send a copy of the following items:

- Insurance Card (front and back copy required)
- Form of identification -Driver's license, Birth Certificate, Social Security Card (if available)
